As long as the BIN Controller Identifier is issued by EMVCo to BIN Controller and the registration has not expired, BIN Controller may state to third parties that the BIN Controller Identifier is “registered” with EMVCo for BIN Controller for purposes of Payment Account Reference governance. BIN Controller will not suggest or imply to any third party that EMVCo has evaluated, approved, certified or otherwise endorsed BIN Controller or its Payment Account Reference governance.

Issuance of a BIN Controller Identifier alone is not sufficient for a BIN Controller to implement Payment Account Reference. The BIN Controller should to work with Card Issuers and potentially Payment Networks to ascertain additional program and participation requirements.


